## **Governance Arrangements**

The Trustees have established committees (Local Governing Bodies and Finance & Planning Committee) either with delegated authority to make decisions or for the purpose of providing advice and support, informing the overall work of the Trust Board. However, these committees are not legally responsible or accountable for statutory functions – the Trust Board retains overall accountability and responsibility.

The responsibilities of board committees are set out in their terms of reference; The Trust Board will appoint committee members and Chairs.

Delegation can be removed if trustees determine that a committee is unable to meet key performance indicators.

The purpose of the Governing Body is to provide independent oversight of the management and operation of each academy, with the aim of improving the quality of education provided and raising standards.

Executive Leaders and the Senior Leadership Team make the day-to day decisions about running the academies.

Trustees shall ensure that the minimum requirements of committee members (governors) for the academies LGB are:

- Chair
- At least two parent governors
- The Headteacher (ex officio)
- At least one staff governor
- At least one local authority governor
- Any number of co-opted/community governors

**The role of the Governing Body (in line with the scheme of delegation) is:**

- Building an understanding of how the academies are led and managed
- Determine school level policies which reflect the Trusts ethos and values
- Management of risk: establish register, review and monitor

- Monitoring whether the academies are:
  - o Working within agreed policies
  - o Is meeting the agreed targets
  - o Managing its finances and resources well
  - o Engaging with stakeholders
  - o Reporting to the Trust Board

**The Governing Body responsibilities include;**

- Review, approve and monitor the Academy Development Plan (ADP)
- Review, monitor and challenge Headteacher/SLT reports:
- School performance & improvement
- Safeguarding, SEND, other vulnerable groups
- Behaviour, attendance & safety
- Student development

The Governing Bodies are sub committees of the Trust Board. Governance structure & committees are established and reviewed annually by the Trust Board.
